#### **General Guidelines**

- Authors are allowed to submit their work for either Oral Presentation or Poster Presentation. Oral and poster presentations will be held in online mode in parallel sessions categorized under the 6 thematic areas mentioned in the website.
- Authors should upload abstracts to the Conference Management Toolkit System leaving out the names of the authors and their affiliations to make the reviewing process. However, author details must separately be added to the appropriate section of the Conference Management Toolkit System submission page.
- Please note that abstracts bearing author details will be rejected.
- Authors should ensure to leave sufficient space in the Abstract to add author details such as the names and affiliations after the review process for the purposes of final submission.
- Research work presented or published elsewhere will not be considered.
- Authors should add author details after the abstract is accepted for publication (For the purposes of Camera Ready Copy).
- Abstracts will be rejected without any further consideration if there is evidence of plagiarism or AI usage.
- The Editorial Committee of ICMR recommends that all authors verify their abstracts beforehand, against plagiarism and AI.
- Authors should upload the scanned copy of the Author Declaration Form signed by all authors, to the CMT system\_along with the abstract and the extended abstract. The reviewing process will not commence until all the relevant documents and information are submitted legibly.
